### What does the fund invest in?

The fund invests primarily in a diversified portfolio of Canadian and U.S. fixed income securities, equity securities, and mutual funds, that produce income.

### How risky is it?

The value of the fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

#### Risk rating

CIBC Asset Management Inc. has rated the volatility of this fund as **Low to Medium**.

This rating is based on how much the fund's returns have changed from year to year. It does not tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

#### No guarantees

Like most mutual funds, this fund does not have any guarantees. You may not get back the amount of money you invest.

### How has the fund performed?

This section tells you how Series OT4 units of the fund have performed. Returns are after expenses have been deducted. These expenses reduce the fund's returns.

**YEAR-BY-YEAR RETURNS**

This section tells you how Series OT4 units of the fund have performed in past calendar years. However, this information is not available because the fund has not yet completed a calendar year.

**BEST AND WORST 3-MONTH RETURNS**

This section shows the best and worst returns for Series OT4 units of the fund in a 3-month period. However, this information is not available because the fund has not yet completed a calendar year.

**AVERAGE RETURN**

This section shows the value and annual compounded rate of return of a hypothetical \$1,000 investment in Series OT4 units of the fund. However, this information is not available because the fund has not yet completed 12 consecutive months.

**Who is this fund for?****Investors who:**

- seek North American equity and fixed income exposure;
- are looking for income with potential for capital appreciation; and
- are investing for the medium to long term.

**A word about tax**

In general, you will have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan such as a Registered Retirement Savings Plan (RRSP) or a Tax-Free Savings Account (TFSA).

Keep in mind that if you hold your fund in a non-registered plan, fund distributions are included in your taxable income, whether you receive them in cash or have them reinvested.

**How much does it cost?**

The following tables show the fees and expenses you could pay to buy, own, and sell Series OT4 units of the fund. The fees and expenses - including any commissions - can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

**1. SALES CHARGES**

There are no sales charges payable when you buy, switch, or sell Series OT4 units of the fund.

**2. FUND EXPENSES**

You don't pay these expenses directly. They affect you because they reduce the fund's returns.

As at August 31, 2023, the expenses for Series OT4 units of the fund were 0.19% of its value. This equals \$1.90 for every \$1,000 invested.

<b>Management expense ratio (MER)</b> This is the total of the fund's management fee (including the trailing commission) and operating expenses for Series OT4 units of the fund.	0.04%

**More about the trailing commission**

No trailing commission is paid in respect of Series OT4 units.

**3. OTHER FEES**

You may have to pay other fees when you buy, hold, sell, switch, or convert units of the fund.

Fee	What you pay
<b>Management fee</b>	Series OT4 units are available to investors who have entered into, or whose representative's firm or discretionary manager has entered into, a Series OT4 unit agreement with CIBC Asset Management Inc. The management fee is negotiated with and paid by, or as directed by, Series OT4 unitholders, or representative firms and discretionary managers on behalf of Series OT4 unitholders. Such management fee will not exceed the annual management fee rate for Series FT4 units of the fund (0.20%).
<b>Short-term trading fee</b>	Up to 2% of the value of units you sell or switch within 30 days of buying them. This fee goes to the fund.
<b>Switch fee</b>	If you sell units of the fund to buy units of another fund managed by us or our affiliates, you may pay a switch fee of up to 2% of the value of units you switch. This fee goes to your representative's firm.
<b>Conversion fee</b>	If you convert units of the fund to another series of units of the same fund, you may pay a conversion fee of up to 2% of the value of units you convert. This fee goes to your representative's firm.

**What if I change my mind?**

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual funds within two business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, Fund Facts document, or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
